Guardianship in NYS

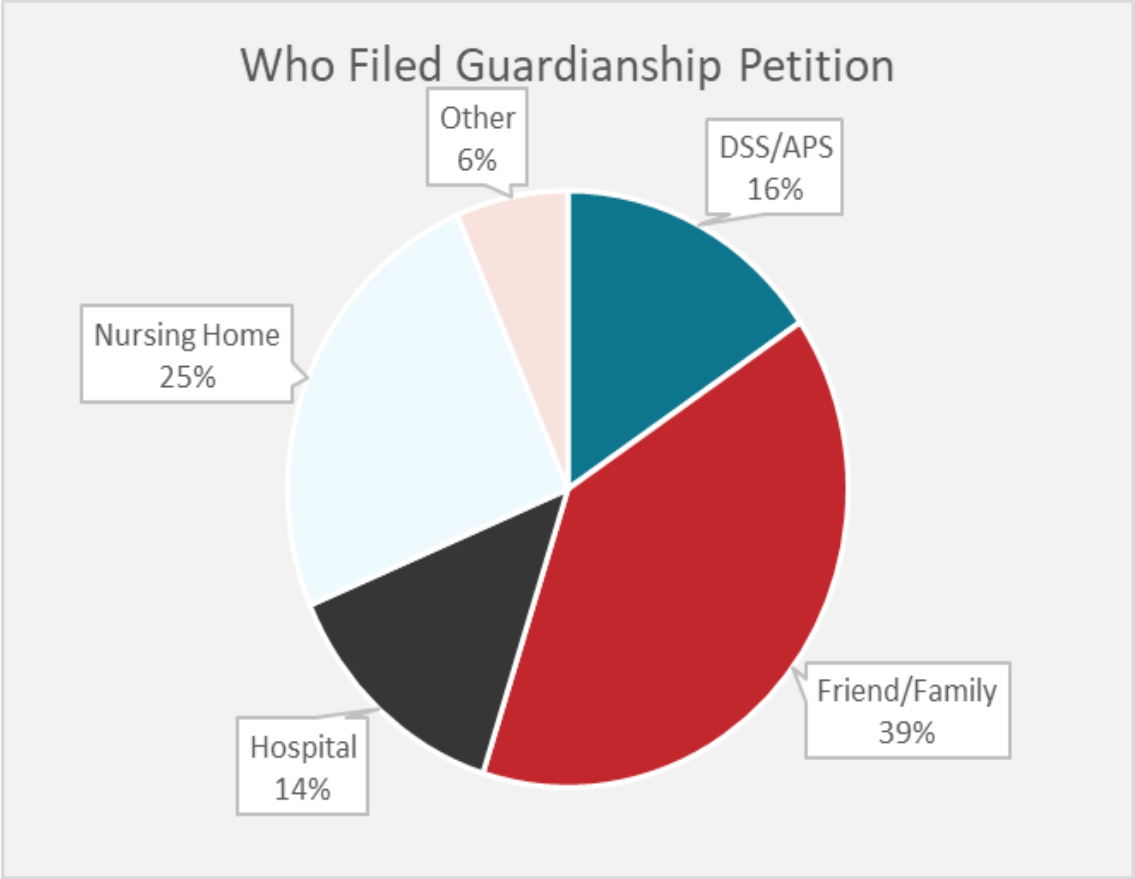


- Legal tool created by Article 81 of NYS Mental Hygiene Law
- Tool of last resort
- Process can be expensive and time-consuming
- No official public guardianship program

June 2018-Feb. 2022



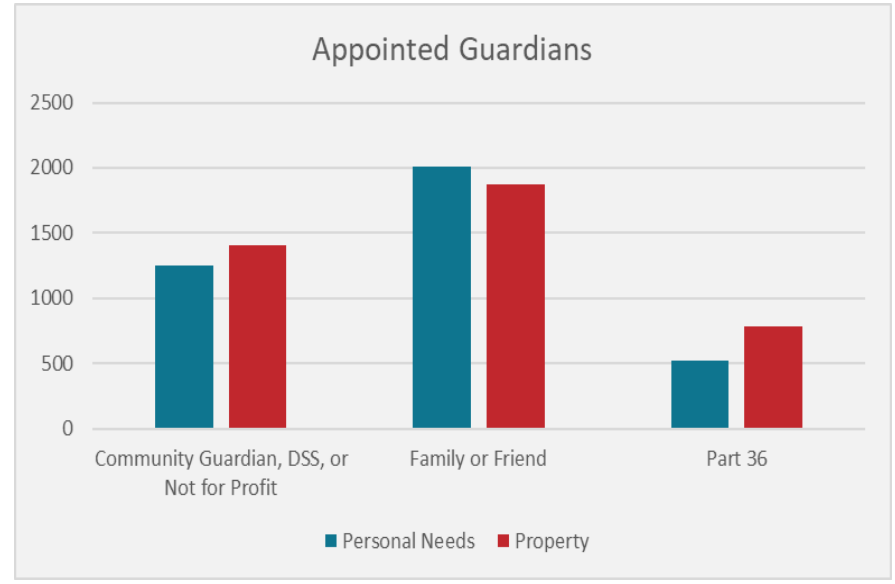
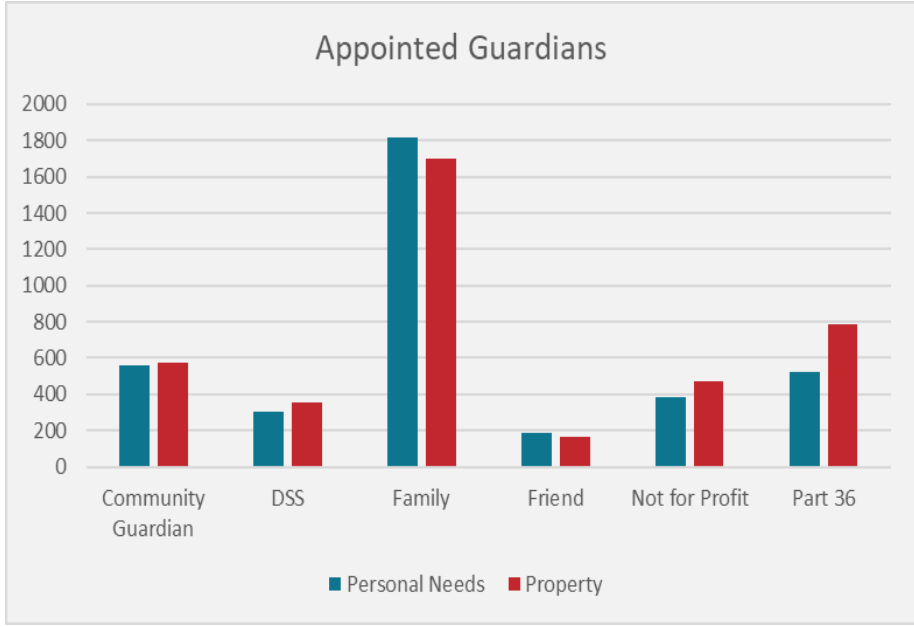
Types of Guardians

 - Nonprofit Agency Guardian Programs



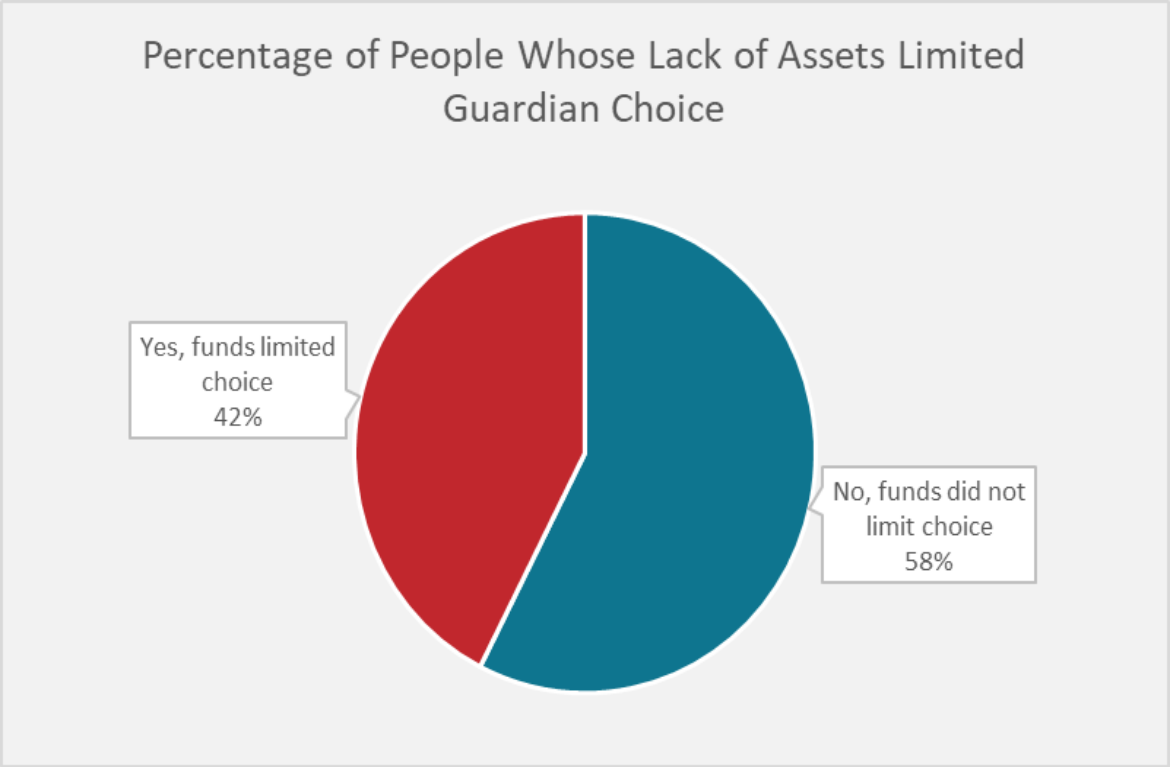
Who is appointed as Art. 81 Guardian?

- Maximize autonomy
- Move back home/stay home
- Support end of life process
- No money, no problem
- Excel at the hardest cases
- Serve as co-guardian with family/friends

2018 Report: “Incapacitated, Indigent, and Alone: Meeting Guardianship and Decision Support Needs in New York”

- Big step in organizing advocacy and change
- **Recommendations**: 5 Categories
 - Need for Decision Support and Guardianship Services
 - Who Serves as Guardian
 - Court Process: Barriers to Effective Services and Oversight
 - National Landscape of Public Guardianship Programs
 - PG Model of Guardianship



Implementing the Recommendations

- **2021 Elder Justice Innovation Grant** awarded by ACL to the NYS Unified Court System (UCS) to examine and improve Article 81 Guardianship
 - **Guardianship Reform in the Courts:** Data, Uniform Forms, Education/Training, Statewide survey

Why Good Guardianship and Autonomy Preservation?

- Mandate of exploring lesser restrictive alternatives
- Availability and access to services
- Paradox: Self-determination vs. removal of rights
- “Magic Wand” use of guardianship
- Procedural safeguards to protect the rights of people subject to guardianship proceedings
- Mismatch between client’s complex needs and the expertise of available guardians



G-GAP: Goals

- Reduce reliance on guardianship
- Fill gaps in continuum of care
- Increase access to alternative decision-making support options
- Ensure equitable access to good guardianship when needed



Why this group of people/orgs?

- Intersection of sectors: health and care coordination, mental health, aging, disability, housing, women's issues, LGBTQIA, finance, civil and criminal legal systems,...
- Viewpoints across the continuum of care
